Regarding: umpires invitation ADIDAS Dutch International 2022

### Dear Friends,

We have the pleasure to invite one of your umpires to the **ADIDAS Dutch International 2022** from April 13 - April 16 2022, a BEC International Series tournament.

The tournament venue: Velo Hall, Noordweg 26, 2291 EE Wateringen Lodging: holiday resort Kijkduinpark, Machiel Vrijenhoeklaan 450, 2555 NW Den Haag

The umpires are expected to attend the Umpires' briefing and are expected not to leave the tournament before the last match has finished.

# All invitations are on the following terms:

- 1. Any travelling-allowances will be on account of the umpires' own national association.
- 2. The organization provides transport from Amsterdam and Rotterdam airports and from Den Haag railway station to the holiday park or sports center.
- 3. Umpires are offered bed and breakfast in 4 or 6 persons bungalows.
- 4. The organization will pay the umpires a compensation of € 125,- which will be paid on Wednesday April 13.
- 5. Umpires have to wear the all black uniform.

#### Covid-19

Should the event be cancelled with short notice due to the Covid-19 situation, beyond the control of ADIDAS Dutch International, Badminton Nederland and Badminton Europe, none of them will be liable for any costs related to travelling or accommodation made by the umpire for this event.

All costs in connection to necessary Covid tests for coming to or departing from the Netherlands have to be borne by the umpire or his/her association.

The tournament will be organized according to the Covid-19 measures present at that time. Towards the tournament we will regularly update the information available on our website.

## Quarantine exceptions:

For participants, coaching staff and officials of the ADIDAS Dutch International, there is an exception to the quarantine obligation, which applies to these high risk countries.

What do you need to do to qualify under this exception?

- 1. Every participant, coaching staff and official needs an official letter of invitation from the Netherlands Olympic Committee (NOC\*NSF) to enter the Netherlands. To this end, we will send a separate form to the countries where this applies after registration for the ADIDAS Dutch International has been closed. To fill in that form we need the following information per person: name, role (athlete or supervisor), passport number, date of birth, date of travel, place of origin, date of departure and travel destination.
- Every person must complete the 'quarantine declaration' form and be able to hand it over to the authorities upon arrival in the Netherlands. You can find this form at https://www.government.nl/topics/coronavirus-covid-19/documents/publications/2021/05/26/quarantine-declaration
